**2011 Food Vendor Policy**

**Set-up:** Food Vendors will be allowed to set-up 6am – 10am on Friday, July 8, 2011.

**Payment:** United Maine Craftsmen, Inc. (UMC) asks for a flat fee of \$300 payable to United Maine Craftsmen with this application. No additional percentage of gross sales will be collected.

**Electricity:** A \$50 electric hookup fee is required. All vendors must supply their own cords. No generators allowed per the City of Bangor.

**License & code requirements:** All Food Vendors must have a temporary City License through the City of Bangor clerks office, and adhere to the Bangor Fire Departments code requirements.

**Food Vendors Insurance:** All Food Vendors must carry insurance. **United Maine Craftsmen needs to be listed as the certificate holder.** Copies of insurance binders must be mailed to UMC by June 1, 2011.

**Display Appearance:** All displays must be neat in appearance. You must provide your own complete display set-up, tables, etc. Tables must be covered to the floor/ground on all sides. Please use only the space for which you have applied, including canopies, overhangs, etc. Food Vendors must keep the area around the food booth clean at all times. Food Vendors are required to remove all their trash, including booth materials and deposit it in the designated dumpsters.

**Management Rights**

UMC reserves the right to determine whether or not a particular product or item is inappropriate for sale and, based on that right, may direct that or any such product or item to be removed from the premises.

UMC further reserves the right to remove any vendor who does not comply with UMC and/or the City of Bangor and/or the State of Maine Policies, Rules, Regulations, Bylaws or Statutes.

**Agreement:**

I have read all of the above policies and agree to abide by them as condition of participation. I understand that once accepted, all fees and deposits are non-refundable. I also understand that United Maine Craftsmen Inc., and The City of Bangor are not liable for any damage, theft or injury.
